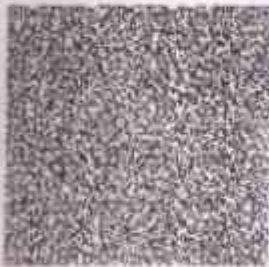

THIS INDENTURE is made at New Delhi this 18th day of November, 2015, by Mr. Pradip Burman, s/o Late Sh. R.C. Burman, R/o A-5/3, Vasant Vihar, New Delhi-110057, hereinafter referred to as the "the Settlor" (which expression shall unless excluded by or repugnant to the subject of context be deemed to include his legal heirs, executors, administrators, assigns and representatives);


WHEREAS THE SETTLOR above named is desirous of creating and establishing a public charitable trust.

AND WHEREAS THE SETTLOR is desirous of settling for Public Charitable purpose a sum of Rs 1,00,000/- (Rupees One Lac only)

AND WHEREAS THE TRUSTEES hereinafter named have agreed and consented to act as the first trustees of these presents as testified by their being parties to and executing these presents and have agreed to accept the office of the Trustees for the purpose of carrying out the wishes of the SETTLOR of the Trust under the provisions and directions set forth herein, so as to enable to pursue its vowed objects.

NOW THIS INDENTURE WITNESSETH that with a view to perpetuate the said desire and in consideration of the premises and for other diverse good causes and consideration the 'Settlor' does hereby grant, assign transfer and hand over to the Trustees and the Trustees do hereby accept and take possession of the said sum of Rs. 1,00,000/- (Rupees One Lac only) (hereinafter for brevity's sake called "the Trust Fund" which expression shall include all accretions thereto by way of interest, dividend, rent, gifts donations or otherwise and the investments for the time being representing the same) and to HOLD the Trust Fund upon the trusts and with and subject to the powers, provisions, agreements and declarations hereinafter contained of and concerning the same.

The Trustees shall hold and stand possessed of the above said Trust Fund upon Trust to receive the interest, dividends, rents, profits and other income thereof and thereon subject to the Trust of these presents and to apply the said interest, dividends, rent,

1. Name

Name of the Trust shall be Mobius Foundation (hereinafter referred to as "the Trust").

2. Office

The Principal Office of the Trust shall be situated in the State of Delhi, at 4th Floor, Punjabi Bhawan, 10 Rouse Avenue, New Delhi - 110002. The Trust may also carry on its work at any other place or places, as decided by the Trustee/s.

3. FIRST TRUSTEES

The following persons shall be the First Trustees of the Trust

1. Pradip Burman,


2. Abhay Agarwal,

3. Universal Trustees Private Limited having registered office at A/902, Marathon Futurex, N.M.Joshi Marg, Lower Parel, Mumbai 400013.

During the life time of Mr. Pradip Burman who is the Settlor of the Trust, he shall have the absolute rights to appoint such other persons to act as Trustees as he may consider prudent, subject to a minimum being not less than three and the maximum number of the Trustees being seven. After the life time of Mr. Pradip Burman, the existing Trustees of the Trust may by unanimous consent co-opt such other persons as Trustees as may be considered prudent, subject to the maximum number of Trustees remaining seven.

4. OBJECTS

Without prejudice to the generality of the foregoing objects or purposes but subject as aforesaid, it is declared that the objects mentioned herein after are independent of each other and the Trustees shall each year apply the net income of the Trust Fund and may at their discretion at any time and from time to time apply also the Trust Fund or any part or parts of the Trust Fund in or towards any



MAIN OBJECTS


1. To promote and encourage knowledge, understanding and enjoyment of the natural environment and public participation and interest in sustainability action which without limiting the foregoing, includes

 - providing or assisting in providing premises, equipment and expertise for the presentation of information or research relating to any aspect of the natural environment and/or education for sustainability;
 - the development, construction, use, operation, maintenance and promotion of land or premises used to further education information provision and/or research in respect of education for sustainability and conservation of the natural environment.
 - Promotion of education & development of novel methods of education
2. To ensure environment sustainability, ecological balance, protection of flora and fauna, animal welfare, agro forestry, conservation of natural resources and maintaining quality of air, soil and water.
3. To undertake activities for sensitizing people to preserve the natural resources of our nation and to maintain the ecological balance of the area.

4. To undertake environmental awareness, energy and natural resources saving, health and safety and social responsibility.
5. To undertake conservation, creation, restoration, expansion and enhancement of the natural environment.
6. To stimulate sustainable livelihoods with the use of appropriate technologies and in built conservation of natural and cultural heritage.
7. To create and produce new products, tools and techniques that will prove the practice of sustainable development.
8. To document, publish, exchange and spread the learning acquired through research and development activities through journals, symposiums, seminars, training, programs and educational workshop.
9. To undertake programs to protect the environment and to make use of the non-conventional energy sources to process sustainable development.
10. To assist the people in need to undertake improved animal husbandry, cottage and small scale industries and cooperative ventures to enhance their economic conditions and to effect sustainable development.
11. To initiate and promote literacy, non-formal education, general awareness education specifically on environment protection/ sustainable development/ use of alternative energy resources.
12. To establish, maintain, run, develop, improve required infrastructure, buildings and other assets necessary to carry out the objectives of this Trust.
13. To print and publish books, pamphlets, leaflets, magazines, periodicals, journals etc. on the activities, development and other common issues pertaining to the objects of the Trust and distribute them free or at cost to public.
14. To take up environmental education program for students, youth, women, NGO's and so on and to undertake nurseries and the plantation program in order to safeguard the natural resources.
15. To undertake income generation program for the benefit of people living below poverty line, unemployed, farmers, agricultural coolies etc.
16. To undertake and encourage gross root level innovations in the field of agriculture, animal husbandry etc.






- VIII. To carry out or any of the aforesaid objects without any distinction of colour, caste, community, creed, religious, race or sex in any part of India or the world either as principal or through agents or in collaboration with universities, municipalities, district board, central and state government, religious or charitable or philanthropic trusts, institutions or organization or otherwise.
- IX. To give provide and or render food, medicine and other help and/or assistance in any shape or form to the poor deserving and needy persons.
- X. To give, provide and/or render monetary and/or other help and assistance for the relief of persons and animals affected by natural and other calamities such as flood, fire, famine, cyclone, earth-quake, storm, accident, pestilence, drought, epidemic, unbearable cost of living and the like, to give donations, subscriptions or contributions to institutions, establishment, centres or persons doing relief work on such occasions.
- XI. To start, maintain and assist any relief measures in those parts which are or become subjected to natural calamities such as flood, fire, drought, famine, cyclone, earth-quake, epidemic, storm, accident, pestilence, etc.
- XII. To establish, maintain or grant aid for the establishment or maintenance of wells , tube-wells, tanks, water-reservoirs and trees and constructions of and repairs to paths, roads, bridges, etc. for the use of the public.
- XIII. To give, provide, distribute dhosis, blankets, rugs, woolen clothings, quilts of cotton, woolen, silk, or other varieties of cloths or other articles of necessity and facilities for the poor.
- XIV. To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or running schools, colleges, lecture halls and other establishments or institutions for advancement of education and of knowledge in arts, science, literature, humanities and all other useful subjects in all their manifestations.
- XV. To open, found, establish, promote, set-up, run maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running hospitals,

- XVI. To promote, advance and encourage and/or aid in helping, promoting, advancing and encouraging primary secondary and higher education including technical and medical education also physical training, training of handicrafts, fine art and other useful arts, crafts among the public including the establishment and maintenance of Shilpa-Shikshalayas, Kala-Kendras and other welfare centres for them.
- XVII. To foster and encourage education and training in handicrafts, fine arts, among women folk in general and establish and found institutions imparting such education and to establish, maintain, support or help by monetary gifts or otherwise, centres and institutions for women and children and to provide social welfare works for women and children.
- XVIII. To meet travelling, boarding and lodging expenses for students going abroad for higher commercial and technical education.
- XIX. To grant, pay or give scholarship, stipends, prizes, rewards, allowance and other financial assistance or help in cash or kind to students with a view to help them in prosecuting their studies in schools, colleges, educational institutions, technical institutions, art schools, institutions teaching commercial and other arts including teaching of cultural arts or other training, research or education works in India or abroad.
- XX. To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running hospitals, charitable dispensaries, maternity homes, child welfare centres, convalescent homes, sanatoriums, hostels and other similar institutions or centres for rendering or providing medical relief and/or aid to the suffering humanities or for research centres and institutions for promotion of research and education for medical science including surgery.

To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running by monetary gifts or otherwise, centres, stadium, playgrounds and parks for public use sports, ~~and~~ games and other social welfare and/or activities in India.

- XXII. To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running institutions, centres, auditoriums and the like for the running of welfare and other services to the public and to provide meeting-room for socially useful activities and functions.
- XXIII. To open, found, establish, promote, set-up, run, maintain, assist finance, support and/or aid or help in the setting up establishment, maintenance and/or running Dharamsalas, wells, deep tubewells, tanks, roads, etc.
- XXIV. To promote, organize, administer, establish, support, maintain, and/or grant aid to any person, institution or society or organization whatsoever having for its objects of charitable purposes and to incur expenditure in connection therewith.
- XXV. To renovate or repair any such temple, mosque, gurudwara, church or other places which is notified by the Central Government in the Official Gazette to be of historic, archaeological or artistic importance or to be a place of public worship of renown throughout any State or States.
- XXVI. To promote, assist and/or maintain all activities by whosoever carried on or wherever carried on in India in conformity with the objects of the Trust and as are conducive to the well-being and general welfare of the nation or are conducive for advancement of any object or objects of general public utility not involving/ carrying on any activity for profit.
- XXVII. To help in the preservation of cattle and useful animals.
- XXVIII. To publish and or publishing books, pamphlets, periodicals and newspaper in or outside for the spread and advancement of education and culture.

5. TRUST FUND AND TRUST PROPERTIES

The Trust Fund/ Properties shall be.-

- a. the said sum of Rs. 1,00,000/- (One Lacs) above referred to the receipt of which is hereby acknowledged by the Trustees.
- b. any properties movable or immovable, that may be acquired by the Trust either by purchase or otherwise.
- c. all additions and accretions to the Trust fund and income thereon.
- d. all voluntary donations both towards corpus or otherwise gifts, legacies or grants in cash or in kind accepted by the trustees.

- e. all grants and contributions made to the Trust by the Government, Government bodies, Trust or Institutions, Trade Union or Societies .
- f. all sums and assets which by any means become the property of the Trust.


The Trustee/s may accept donations, grants, subscriptions, aids or contributions from any person in cash or in kind including immoveable property without any encumbrance, but the Trustee/s shall not accept any receipts contrary to the objects of the Trust, the Trustee/s shall respect the directions, if any, of the Settlor. Any receipt with specific direction to treat the same as part of corpus of the Trust or separate fund shall be treated accordingly.

6. AREA OF THE OPERATIONS

The activities of the Trust shall be only within India and its Union territories and shall not be extended anywhere outside India.

7. MANAGEMENT OF THE TRUST


- i. The Trust will be managed by a Board of Trustees and the parties of the Second Part being the first trustees shall constitute the Board of Trustees and the number of trustees at any given time shall not be less than three or more than seven. The quorum for meeting of the trustees shall require presence of at least one half of the total strength of the Trustees or three trustees, whoever is higher.
- ii. The Board of Trustees may be expanded by the Board of Trustees, in accordance with clause (xii), provided hereinafter;
- iii. Any Trustee, including the First Trustee, may retire from the Trusteeship hereof by giving two months' notice in writing of his or her intention to do so, to the Board of Trustees and after the expiry of notice, the Trustee shall cease to be a Trustee of these present. Notwithstanding anything contained hereinabove, a shall retire at the age of 75 years provided the Trustees may, by a majority vote extend the tenure of such a retiring Trustee by another 5 years.
- iv. In the event of a vacancy caused by death, expiry of term of office or resignation, the remaining Trustees shall fill up the vacancy so as to have minimum number of trustees.
- v. Subject to Applicable Indian Laws, the vacancy caused by death, expiry of term of office or resignation shall be filled up in a manner that effort shall be made to ensure there shall be at least One Trustees on the Board of

Trustees who is a member of the Burman Family. In the event of retirement or resignation of a trustee who is a member of Burman family, the outgoing Burman Trustee shall have the option to nominate another Burman family member to fill up the vacancy and any such nomination shall be binding on the remaining Trustees. If however no such nomination is made by the outgoing Trustee, then the vacancy created shall be filled up in accordance with the stipulations contained in this Trust Deed. However to fill up the vacancy created by the resignation, death or retirement of a Burman Trustee, preference shall be given to any incumbent who is a member of Burman family over any other non family incumbent.

- vi. Every Trustee shall serve on the board up to his attaining the age of 75(seventy five) years whereafter he shall be eligible for reappointment for a further period of five years, if in the opinion of the majority of remaining Trustees he is in a position to effectively discharge his duties as a Trustee.
- vii. Every Trustee shall be liable to retire as Trustee upon his attaining the age of eighty years;
- viii. Subject to the stipulations contained hereinafter, the Board of Trustees shall have the power to remove any of the Trustees suffering from physical or mental disability or if he is accused of misfeasance of trust funds or property or misconduct, after satisfying on enquiry and such decision of the Board of Trustees, taken in accordance with the stipulations contained herein shall be final.
- ix. That all the Trustees of the Trust shall jointly constitute the Board of Trustees. All questions arising at a meeting of the Trustees shall be decided by simple majority of the Trustees present in a meeting and the decision of the said Trustee shall be considered final and shall be binding on everyone concerned. The proceedings of the Board of Trustees shall not in any way be invalidated due to any post or posts remaining vacant. During the time when a vacancy is yet to be filled up, the remaining Trustees shall act as "Full Board", subject to the presence of Quorum in the meetings. Any vacancy in the Board of Trustees or illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board.
- x. Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of majority of total number of Trustees at a given time shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
- xi. Any of the powers and authorities by this settlement given to or vested in the Trustees may at any time when there are more than one Trustee be exercised by a majority of the Trustees without the concurrence, or with

merely the formal concurrence of any Trustee who by reason of illness, infirmity or otherwise may be unable, without inconvenience, to take an active part therein and such Trustee may in order to facilitate business by Power of Attorney or otherwise, empower any of the other Trustees to use his or her name for execution or signature of documents Trustees to use his or her name for execution or significance of documents for any of the purposes of this Trust and all the acts and proceedings of the majority of the Trustees shall be in such case be valid and effectual as if they had all concurred therein.

- xii. Any Trustee hereof who shall dissent in the exercise of any of the powers or authorities aforesaid from other Trustees shall nevertheless concur in executing or signing any documents or any of such powers or authorities by the majority of the Trustees without being responsible for the loss to the trust that may be caused. All the acts, proceedings and exercise of discretion of the majority of the Trustees shall be absolutely binding on the remainder of the Trustees.
- xiii. Notice of every meeting with the proposed agenda in writing shall be sent to all Trustees. A resolution shall be considered as validly passed only if it is approved by not less than one half of the total number of Trustees eligible to vote, who have voted for it either in person or through circulation.
- xiv. The following items of business shall be treated as "reserved matters" and shall be considered only at the meeting attended by at least two third of the total number of trustees in office at the time and any decision pertaining to Reserved Matters shall be taken by not less than two thirds of the Trustees present in such Meeting. No decision on Reserved Matters shall be taken through a resolution passed by circulation. .
- a. Approval of Financial Statements of the Trust
 - b. Appointment of Additional Trustees
 - c. Filling of casual vacancy
 - d. Disposal of the capital assets of the Trust
 - e. Borrowing by way of loans, secured or unsecured.
 - f. Increase in the number of Trustees.
 - g. Removal of a Trustee.
- xv. Any defect in the constitution of the Trust shall not invalidate its proceedings.
- xvi. In all cases of difference of opinion amongst the trustees as to whether a particular act should be done or omitted to be done in the execution of the trusts hereof or as to the powers and authorities herein contained or as to the true intent and meaning of any of the clauses of trusts hereof the same

The trustees shall not accept any donation, the terms and conditions of which are contrary to the inconsistent with the objects of this trust.


8. POWERS AND DUTIES OF TRUSTEES

The Trustee/s shall have full control of management of all the affairs of the Trust and of the income, assets and funds of the Trust. Without prejudice to the generality of the foregoing, the Trustees may exercise all or any of the following powers:

- IX. To appoint, suspend, dismiss or otherwise deal with staff of all kinds required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out of the objects of the Trust.
- X. Appoint consultants to assist/enable them to carry out their functions and duties.
- XI. Act upon any advice obtained in writing from any bankers, accountants, brokers, lawyers, professionals, consultants or other experts acting as advisors to the Trustee(s).
- XII. To borrow any moneys from any person Firm, Company or Body for any of the purposes of the Trust on such, terms as the Trustees may deem fit and with or without furnishing securities and in particular to mortgage or ~~change~~ any property or assets, movable or immovable of the Trust vested in



- XX. It shall be lawful for the Trustee/s to carry out any of the objects of the Trust either directly by themselves or by Institution run by the Trust and others jointly or in cooperation or by making contributions to or subsidizing any institutions carrying out any similar objects or aims provided that such funds or institutions are also charitable institutions and satisfy tax laws for the time being in force granting exemptions.

The Trustee/s may nominate one or more persons of themselves either by name or otherwise to be in custody of any of the assets of the Trust in his on their names for and on behalf of the Trust and / or to execute all documents, contracts and deeds for and on behalf of the Trust. 

16. IRREVOCABLE TRUST


